



United Way Home For Good Santa Barbara County & Santa Barbara County AmeriCorps Partnership Acknowledgement of Volunteer Responsibility, Express Assumption of Risk, and Express Release of Liability

In consideration for being allowed to participate as a volunteer with the United Way of Northern Santa Barbara County programs: Santa Barbara County AmeriCorps Partnership (AC), Home For Good Santa Barbara County (HFG) and Common Ground Santa Barbara County (CGSBC) on behalf of myself and my next of kin, heirs and representatives, **I release from all liability and promise not to sue** the County of Santa Barbara, Cities and other participating organizations of AC/HFG/CGSBC, and collectively its' contractors, employees, officers, directors, volunteers and agents from any and all claims, including claims of negligence, resulting in any physical or psychological injury (including paralysis and death), illness, damages or economic or emotional loss I may suffer because of my participation with AC/HFG/CGSBC, including travel to and from and during outreach.

I am voluntarily participating with AC/HFG/CGSBC. I am aware of the risks associated with traveling to/from and participating with AC/HFG/CGSBC, which include but are not limited to physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and/or death. I understand that these injuries or outcomes may arise from my own or other's actions, inaction, or negligence; conditions related to travel; or the condition of the AC/HFG/CGSBC location(s). **Nonetheless, I assume all related risks, both known or unknown to me, of my voluntary participation with AC/HFG/CGSBC, including travel to, from and during AC/HFG/CGSBC outreach.**

I agree to hold the AC/HFG/CGSBC Staff harmless from any and all claims, including attorney's fees or damage to my personal property that may occur as a result of my voluntary participation with AC/HFG/CGSBC, including travel to, from and during AC/HFG/CGSBC outreach. If the AC/HFG/CGSBC Staff incurs any of these types of expenses, I agree to reimburse the AC/HFG/CGSBC Staff. If I need medical treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In consideration for my acceptance as a participant the AC/HFG/CGSBC outreach, and the services and amenities to be provided by the AC/HFG/CGSBC Staff in connection with the CGBSC outreach, I confirm my understanding that:

- I have read any rules and conditions applicable to the AC/HFG/CGSBC outreach made available to me and I acknowledge my participation is at the discretion of the AC/HFG/CGSBC Staff.
- The AC/HFG/CGSBC outreach officially begins and ends at the location(s) designated by the AC/HFG/CGSBC Staff. The AC/HFG/CGSBC outreach does not include carpooling, transportation, or transit to and from the AC/HFG/CGSBC outreach, and I am personally responsible for all risks associated with this travel.
- If I decide to leave early and not to complete the AC/HFG/CGSBC outreach as planned, I assume all risks inherent in my decision to leave and waive all liability against the AC/HFG/CGSBC Staff arising from that decision. Likewise, if the AC/HFG/CGSBC Staff has concluded the AC/HFG/CGSBC outreach, and I decide not to return to the end location designated by the AC/HFG/CGSBC Staff, I assume all risks inherent in my decision to go forward and waive all liability against the AC/HFG/CGSBC Staff arising from that decision.

- This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
- To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY the AC/HFG/CGSBC Staff, its officers, directors, employees, agents, and leaders from any and all liability on account of, or in any way resulting from Injuries and Damages, even if caused by negligence of the AC/HFG/CGSBC Staff, its officers, directors, employees, agents, and leaders, in any way connected with the AC/HFG/CGSBC outreach. I further agree to HOLD HARMLESS the AC/HFG/CGSBC Staff, its officers, directors, employees, agents, and leaders from any claims, damages, injuries or losses caused by my own negligence while a participant in the AC/HFG/CGSBC outreach. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns.
- I have read this document in its entirety and I freely and voluntarily assume all risks of such Injuries and Damages and notwithstanding such risks, I agree to participate in the AC/HFG/CGSBC outreach.

I do hereby consent and agree that the AC/HFG/CGSBC Staff, its employees, or agents have the right to take photographs, videotape, or digital recordings of me during AC/HFG/CGSBC outreach and to use these in any and all media, now or hereafter known, and exclusively for the purpose of the AC/HFG/CGSBC Staff. I further consent that my name and identity may be revealed therein or by descriptive text or commentary.

I do hereby release to the AC/HFG/CGSBC Staff, its agents, and employees all rights to exhibit this work in print and electronic form publicly or privately and to market and sell copies. I waive any rights, claims, or interest I may have to control the use of my identity or likeness in whatever media used.

I am 18 years or older or my parent or guardian has agreed to my participation. **I/or my parent or legal guardian understand the legal consequences of signing this document, including (a) releasing the AC/HFG/CGSBC Staff from all liability, (b) promising not to sue the AC/HFG/CGSBC Staff, (c) and assuming all risks of voluntarily participating in the AC/HFG/CGSBC outreach including travel to, from and during the AC/HFG/CGSBC outreach.**

I understand that this document is written to be as broad and inclusive as legally permitted by the State of California. I agree that if any portion is held invalid or unenforceable, I will continue to be bound by the remaining terms.

I have read this entire document and I am signing it freely. No other representations concerning the legal effect of this document have been made by me.

Confidentiality Agreement

As part of your work with the SBC AmeriCorps Partnership (AC)/Common Ground Santa Barbara County Homeless (CGSBC) you may have access to view, update or modify sensitive information about the AC/HFG/CGSBC Process and the AC/HFG/CGSBC Staff, its partners, clients and operation. You must treat this information as confidential and not disclose it with anyone unless specifically authorized in writing by the AC/HFG/CGSBC Staff.

The AC/HFG/CGSBC Staff defines Sensitive Information as including but not limited to:

- Client names, nicknames or any other identifying information
- Client address, location or whereabouts
- Client personal finance information including Social Security numbers, financial data or related information
- Client health information including information on medical conditions, treatment or history
- Information on AC/HFG/CGSBC Staff and AC/HFG/CGSBC Outreach plans and operations

Any information collected, access or viewed, whether it be verbal, written, electronic, printed or any other form, as part of the AC/HFG/CGSBC outreach is to be treated as confidential and must not be disclosed. All information related to the AC/HFG/CGSBC outreach is the property of the AC/HFG/CGSBC Staff and should not be disclosed, released, shared or discussed without prior written authorization from an authorized member of the AC/HFG/CGSBC Staff. This includes communication in any form with clients, co-workers, outside agencies or any other party.

In the event you are unsure if information can be shared, DO NOT DISCLOSE INFORMATION, contact your Team Leader or the AC/HFG/CGSBC Staff management to obtain approval.

Unauthorized disclosure of AC/HFG/CGSBC Staff and/or AC/HFG/CGSBC Process information may result in disciplinary action, legal action and may result in dismissal from the AC/HFG/CGSBC outreach.

Acknowledgment:

As a volunteer participant in the AC/HFG/CGSBC outreach I understand that I may have access to Sensitive Information as determined by the AC/HFG/CGSBC Staff. I agree to maintain the security and confidentiality of survey and related information as well as the security of the AC/HFG/CGSBC Staff IT systems. I will not disclose, share, publish, copy or distribute any survey or AC/HFG/CGSBC Staff and/or AC/HFG/CGSBC Process information without express written permission of an authorized member of the AC/HFG/CGSBC Staff. I will not disclose or share my username or password to AC/HFG/CGSBC Staff systems to anyone for any reason. I will report any questions, issues or suspicious activities immediately to my supervisor or the AC/HFG/CGSBC Staff management.
